CORRIDOR TRANSPORTATION NETWORK PROJECT**

The Pennsylvania Department of Transportation (PennDOT) Engineering District 11-0, in cooperation with the Federal Highway Administration (FHWA), will be holding two Open House Public Information Displays regarding the I-376 Parkway East Corridor Transportation Network Project.

The purpose of the Open House Public Information Display is to introduce the project and study team, share results of recent traffic studies, present the results of public outreach efforts to date, identify the project next steps and gather feedback. Those in attendance at either meeting will also be able to view a presentation offered at 6:00 p.m.

"Now that we've completed several technical studies and gathered the results of the project's online public survey, it's the right time to present our preliminary findings to the public, capture any information we might have missed, and start

considering potential improvement options,” said Dan Cessna, P.E., PennDOT District Executive.

The overall goal of the Project is to perform a comprehensive transportation evaluation of the I-376, Parkway East Corridor Transportation Network extending from the City of Pittsburgh to Monroeville that will be used to develop and design strategies to improve the overall safety and mobility.
